Dear [REDACTED],

In our last phone conversation, you had asked that I inform you of the restrictions that Fr. Frank Dilla has been placed under as a result of his original misconduct and subsequent failure to observe the Cardinal's restrictions.

I have delayed responding so that I might work out with Fr. Dilla the details of his retirement. As of Nov. 1, 1993, Fr. Dilla has submitted his request for retirement and the Cardinal has accepted it. Though he officially remains a priest, Fr. Frank ~~will~~ no longer ~~be~~ on the active role of priests for the archdiocese.

In addition, the Cardinal has ^{determined} ~~decreed~~ that Father Frank's priestly faculties to exercise public ministry are permanently withdrawn. He is forbidden, ~~as a retired priest,~~ to exercise any public ministry liturgically or sacramentally. He is allowed to offer Mass, but only in a private setting.

He also has the following restrictions imposed:

- He must not be in the presence of minors without another adult being present.
- He must abstain from alcoholic beverages.
- He must continue for the rest of his life in his recovery program as determined by competent authorities.
- He will be monitored regularly for the rest of his life [REDACTED] by our office.

In his retirement, he will continue to reside in his home at New Carlisle, Ind. The diocesan authorities in the area where Fr. Dilla lives have been notified of his presence and of the restrictions to which he is subject.

From a priest's point of view, the restrictions of his priestly faculties are quite devastating. For all intents and purposes Fr. Dilla will not function as a priest publicly ever again.

1. I spoke to [REDACTED], this morning. I have been trying to put her in touch with a woman who could take her testimony. She wanted to have a lay person since she did not feel at ease with a religious person. She said her family is very religious and there are nuns in the family. As a result she would feel very squeamish about bringing up some of these details of the alleged abuse.

2. I told her about [REDACTED], whom I have asked as a personal favor to interview her. I talked to [REDACTED] said she'd be willing to do it. [REDACTED] is now going to call [REDACTED] to try to set up an appointment to get the information. I asked [REDACTED] to assure her that:

1) We would be confronting Fr. Dilla on the charges. For that reason the charges need to be as specific and as pointed as possible.

Victim Statement Abstract

This abstract replaces a memorandum and handwritten memorandum dated January 29, 1992, to Fr. Patrick O'Malley, Vicar for Priests of the Archdiocese of Chicago, from an individual asked to meet with Victim MB to formalize Victim MB's allegation of abuse against Fr. Francis Dilla. According to the memorandum, Victim MB alleged that she was abused by Dilla on approximately 50 occasions when Victim MB was in first grade. Victim MB stated that the abuse included genital fondling.

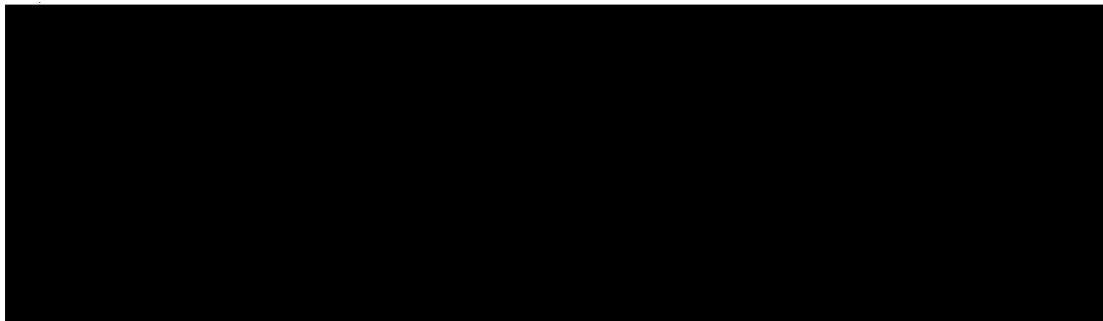

Thank you for coming in last Friday. I know it was a very difficult meeting for you as it was for Andy and myself. Just to go over some of the things that occurred and to remind you of what we agreed upon, I will line those up.

One, I asked you not to be in the presence of minors under 18 without responsible adults being present. This goes for family gatherings as well as all other gatherings.



Five, you have my permission to help Dan Sullivan with the Masses on this coming weekend, but as of February 10, the suspension of faculties is in force.

Six, I ask you to keep in contact with Andy McDonagh about the details of a possible early retirement. We'll have to check out whether you have enough quarters in your Social Security to be eligible for Social Security at 65, but Andy can help you with that.

I hope this is your understanding of what we discussed. Again, I want you to know that Andy and I will work with you throughout this process. We know you have done a lot of good priestly work in the past and that is certainly in your favor.

As for the future, I hope that we can work that out amicably together. I'll keep you in my prayers, Frank, and I ask you to do the same for me.

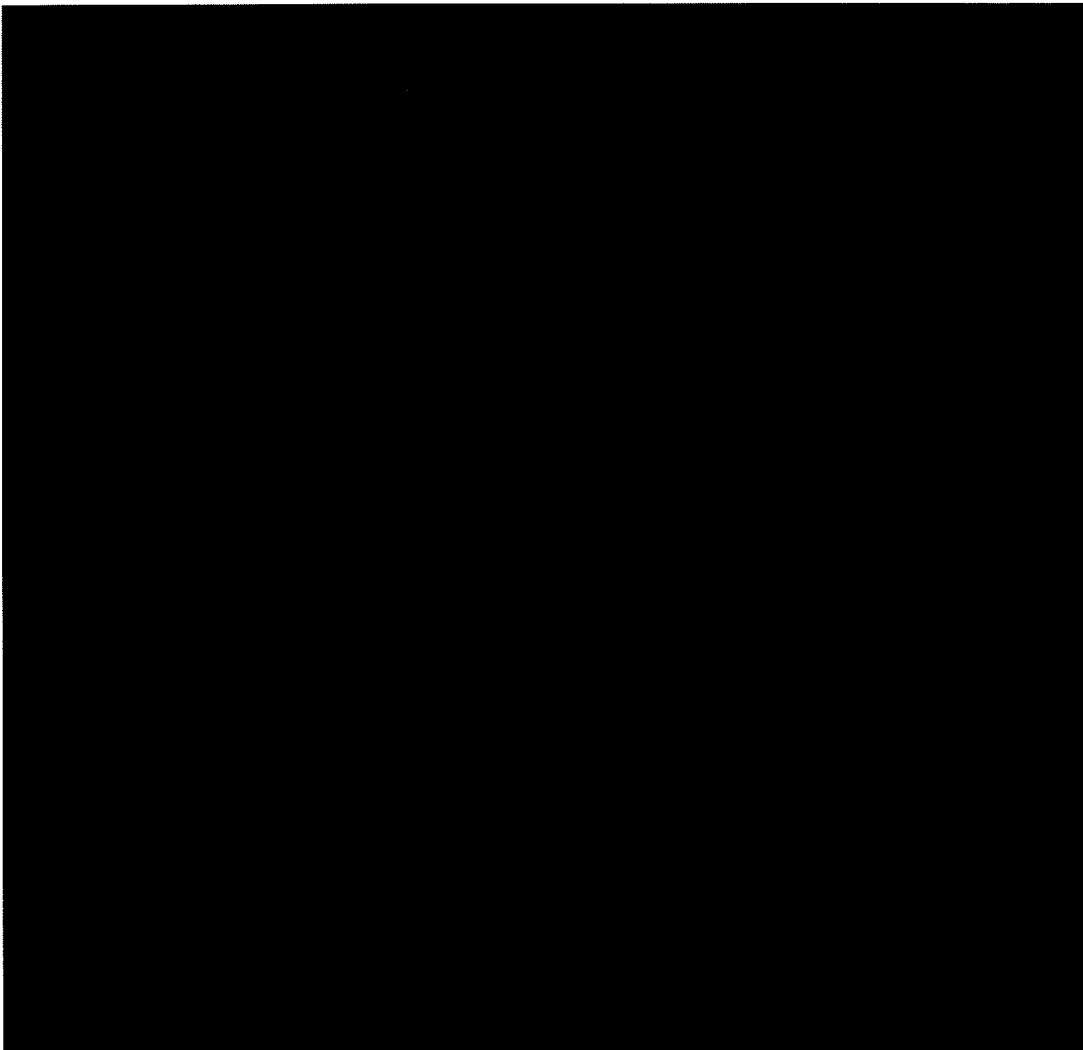

1. Frank Dilla came in to see me today to follow up on our previous meeting and the letter I sent him as a result of that meeting. He admits that after we brought before him the allegation from [REDACTED] was unable to focus on many of the things we were saying. When he received the letter it all came home to him in a very serious way.
2. Frank spent time going back over his ministry so that I could understand all the good things that he felt he had accomplished in his ministry. He reflected on the fact that several of the parishes he served in were no longer about because of different and varying reasons. Frank was obviously upset and outlined for me how he felt that all his years of service were being weighed against these acts with [REDACTED]. He admitted he was guilty but was struggling with the justice of it all.
3. I told Frank that I understood why he would feel that way, but again I went over what had happened to [REDACTED]. I told him that it had been a criminal offense, that he could have been prosecuted at the time and I just very softly tried to inform him of the enormity of what he had done. While he admits that it is very difficult for him to get his head around all the ramifications of that action.
4. I explained to him how, since it had happened in the environment [REDACTED] doing religious actions at this time with the family created something of a problem. There is a wedding coming up of [REDACTED] who has asked him to preside. It's quite probable that [REDACTED] will be present. I do not think we can allow Frank to be the main celebrant of that service. I know it will cause talking, but I know we also have to be alert to feelings of [REDACTED] and her [REDACTED].
5. I told Frank that in the future, if a request for his services comes in regarding someone who is not part of his family, then he should contact me to see if he would be allowed to participate in that service. I am thinking especially of funerals of old parishioners with whom he has been acquainted for many years.
6. I think we were a little more agreeing towards the end of our talk. He will obey what has been asked of him by the Cardinal despite its difficulty. I did tell him that no final decision about his future ministry will be made until after that report is in, at which time we will sit down with him to work out the details.

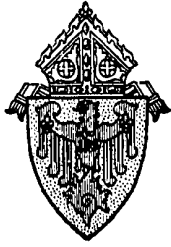

Fr. Dilla came to see me and Fr. Andy McDonagh today. He had several questions. [REDACTED]

A second point was whether there has been any legal action taken by [REDACTED]. We said at this point, no, but that she is continuing [REDACTED].

The third point was about the restoration of his faculties in the future. After a long discussion, during which time Father told us about his past history, we indicated to him that there might be a possibility of a partial restoration of faculties for a limited ministry in the future, given certain parameters. We wish to call your attention to a problem that we have had in the past with regard to the question of salaries and raises for men who have been accused of sexual misconduct with minors and who have been subsequently removed from ministry. These salaries will now be administered under Steve Sidlowski.

If you recall, last year when this question came up, we agreed that they should all receive the regular salary base plus transportation plus stipends plus increment from years in service. We have been operating under that ruling ever since.

We think this is a question that needs further revisiting and so John and I would like to suggest the following:

1. That you approach the Executive Board of the Presbyteral Council with this problem. You would tell them that you wish to have a recommendation from them as to how much men who have been involved in sexual misconduct with minors and who are now limited in their ministry should receive. Because of the nature of this matter, we would not suggest taking it to the whole council.
2. That John Canary and I can work with the council to let them know what we have done in the past.
3. That you ask the Executive Board of the Senate to make a recommendation to you within the next month to six weeks. Their recommendation then, if accepted by you, would become policy for the Fitness Review Administrator in determining what the salaries of the men will be.

We did not wish to bring this matter up before the Advisory Board until we have some further direction from you. Please let us know your will in this matter at your convenience.

I met with Fr. Frank Dilla and his sister, [REDACTED] OFM, the nun who is celebrating her 50th anniversary. I met with them at St. Mary of the Lake from 7:30 pm until about 8:45 pm on June 7, 1993.

[REDACTED] did most of the talking during the session. She commented on the letter that Frank had received. She kept coming back to the fact that, if he had received it earlier and had she been told earlier, she never would have set up so extensive a celebration for her 50th. She would have been satisfied with a reception and would not have needed a celebratory Mass. She feels embarrassed and ashamed and angry about the fact that Frank cannot say the Mass. She was obviously quite upset and I tried to listen as best I could. At one point [REDACTED] began to speak as if [REDACTED] might be the cause of this whole thing, and I assured her in no uncertain terms that [REDACTED] was a victim and not the cause of the problem. I did not want any repercussions to come back to [REDACTED].

Sister asked me if I thought that it would be a good thing for her to go and see [REDACTED]. I told her I did not think so because [REDACTED] need not have any guilt or pressure put on her at this time.

I was able to understand some of the feelings that Sister had. I did make clear to her where the problem lay and who was responsible for this whole problem. While at the end of the meeting she said that she was happy she was able to express her feelings, I am sure that she did not or could not totally express what she felt.

Frank is 65 yrs. old, class of 1953, is presently living in a house he co-owns (I believe) in New Carlisle, Ind. [REDACTED]

Enclosed are pertinent materials regarding his personal situation and the most recent events surrounding his request to celebrate the 50th anniversary Mass for his sister.

Frank has been living in New Carlisle. At the time his actions were discovered in 1992, he was coming off a sabbatical at N.D. He had not been reassigned but was helping out on weekends. We left him at his home, restricted his public ministry [REDACTED]. He has been cooperative to this point. I see him or speak to him occasionally. That is all the supervision he has had.

I should say that Frank lives with a former housekeeper. She and her husband owned this home along with Frank. When the

husband died recently, the arrangement continued. I confronted Frank about any sexual question here. He absolutely denies any sexual involvement with him. Frank has been a pretty sick individual and I do not doubt his word.

Whenever he wanted to offer Mass for a former parishioner, he would ask permission. I would always check whether his family would be involved. If they were, we would say no to him. If not, we would give him specific permission.

Frank visited Steve Sidlowski last Friday and asked him whether he could offer the Mass. Steve told him it was out of his hands and that he could not make any exception.

This is a serious breach of promise. It has hurt [REDACTED] deeply - as well as [REDACTED] who was also abused, but who, up to this time, has not come forward to accuse Frank. According to [REDACTED], she may do so when she returns to Chicago this week.

I met with Father Dilla on June 23, 1993. It was a difficult meeting. He made contradictory statements. One minute, for example, he would say he understood why we were restricting him; the next minute he would say he did not understand. Overall, he does not seem to understand the seriousness of his problem.

He started off by saying that he has complied with all our requests [redacted]. Then he told me that the one thing he did not comply with was the mandate not to celebrate the jubilee Mass for his sister. He complained that he must call you each time for permission to participate in a religious function which does not involve his family. In the case of the anniversary Mass, he said there was pressure for him to celebrate it and he did not know what reason he could give for not celebrating since not all the family and friends know what occurred years ago. Furthermore, [redacted] never attends these family affairs and did not attend the anniversary Mass; so what's the problem, he asked.

He presented himself as an old man who did something wrong many years ago, has repented, is now suffering from many physical ailments and all he has left is his priesthood. While he seems to understand that he can no longer serve in a parish, he can't understand why he cannot celebrate for special events for family and friends. He resented the tone of your May 28th letter.

I explained to him as best I could why we had imposed the restrictions. I also told him that by celebrating the anniversary Mass he had created a problem whose consequences could be and probably would be very serious. [redacted]

He then asked if we could grant him an indefinite sick leave. Then he could use that as an excuse for not accepting invitations. Actually, he has many physical ailments: [redacted] etc. [redacted]

He also complained that neither I or any bishop has contacted him during the time he has been away. He did, however, express gratitude for our meeting as he left. [redacted]

This is just a hurried summary of our meeting. We need to discuss this more at your convenience.

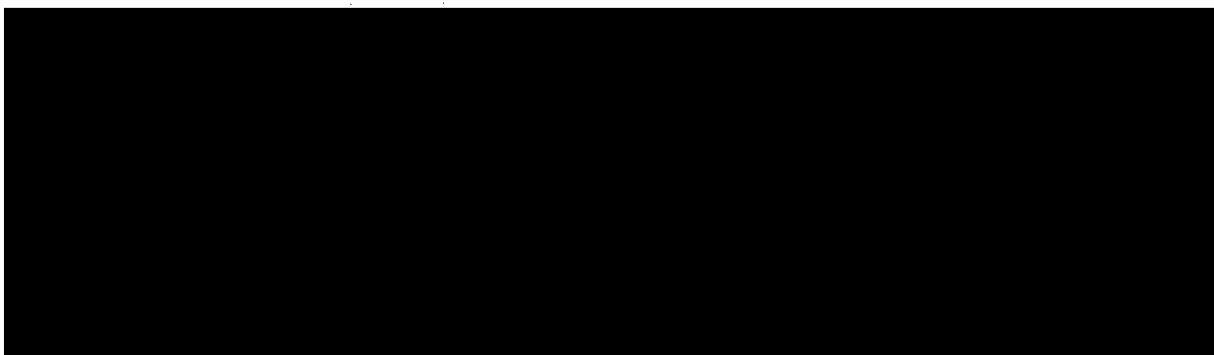

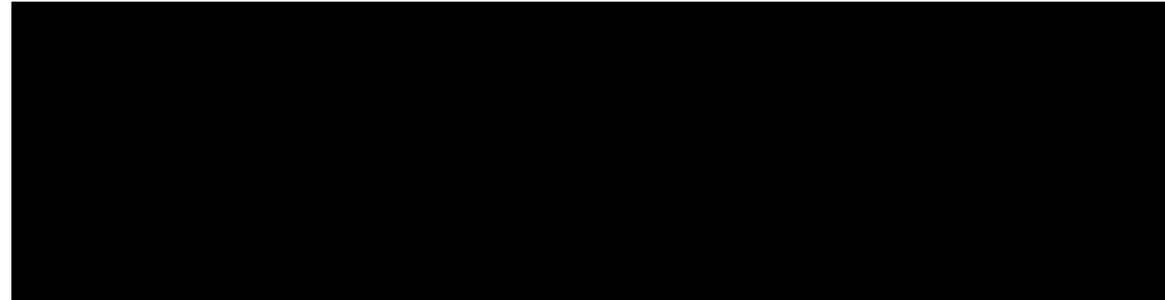

It has come to my attention that you have violated a clear directive of the Vicar for Priests. In order to address this matter, you are asked to meet with Father O'Malley and myself on Wednesday, July 14, 1993 at 2:00 P.M. The meeting will take place in my office on the fourth floor of the Pastoral Center, 155 East Superior Street.

Please note that this meeting will deal with the canonical implications of this violation. As such, the Archdiocese does not foresee any need for a civil attorney or criminal lawyer to be present. If you choose to retain your own civil attorney or criminal lawyer, the Archdiocese has no objection to his or her presence at this meeting, but you would be responsible for any legal fees at your own expense. On the other hand, since this meeting will deal with canonical matters, you may wish to have a canon lawyer present of your own choosing. If needed, the Archdiocese could arrange for a canon lawyer to represent you.

PENAL PRECEPT IMPOSING RESTRICTIONS ON REVEREND FRANCIS E. DILLA

In order to preclude scandal arising from allegations of sexual misconduct with a minor against you and in order to provide adequately for the safety of children and other minors (c. 277);

Mindful of my responsibilities to promote ecclesiastical discipline and urge observance of all ecclesiastical laws (c. 392) through the exercise of my pastoral office as diocesan bishop (c. 381, § 1);

Taking into account the common good of the Church, the rights of others and duties towards others (c. 223 § 1), and the salvation of souls (c. 1752); and

Having heard those whose rights can be injured and having thoroughly considered the information and facts of the matter (cc. 50 and 1319, § 2);

Therefore, I, Joseph Cardinal Bernardin, by the grace of God and the Apostolic See Archbishop of Chicago, hereby revoke your faculties for public ministry as a priest of the Archdiocese of Chicago and impose the following restrictions on you, Reverend Francis E. Dilla, in accord with the norms of canon law, especially canons 49 and 273, as a matter of obedience:

You are forbidden to be alone in the presence of any minor under the age of eighteen without another adult present (c. 277). Due to previous difficulties, you are to refrain from consuming alcoholic beverages (c. 285, §§1-2). While you may continue to celebrate Mass privately, you are forbidden to celebrate Mass or any other sacraments publicly (cc. 838, §1 and 899, §2). In particular, you may not preach, hear confessions or anoint the sick (except in danger of death), assist at marriages, or administer sacramentals (cc. 764; 967, §2; 976; 1003; 1111; and 1168). In addition, you are required to live in any such supervised residence as may be designated by the Vicar for Priests and to follow the protocols established for you.

In accord with canons 1317-1319, 1347 and 1371, 2°, you are warned that intentional or culpable violation of this precept will result in your automatic suspension. Such suspension would prohibit the exercise of all acts of the power of orders (c. 1331, §1, 1°). In addition, your income would be reduced according to the circumstances (c. 1350).

Fr. Thomas Paprocki and I met with Fr. Dilla at 2:00 PM on July 14, to give him the prescript concerning his conduct. Fr. Dilla had disobeyed a direct order from the Cardinal about celebrating a Mass for his sister, a nun. He is now removed from any kind of public ministry except for the saying of Mass in a private setting. He will have to move into the Retreat House by August 1. His salary will be cut back accordingly. He is again placed under mandate not to be in the presence of minors without another adult being present and also not to drink.

This was a very difficult meeting. Fr. Dilla said he wanted to bring this to his lawyers. We gave him the name of Fr. Jerry Listecky at the seminary, who is a Canon Lawyer. We told him that his lawyers really have nothing to do with this since it is a Church prescript. Fr. Dilla obviously needed time to make whatever decisions he has to make. He did speak about retirement, but I pointed out to him that he did not have social security yet and would be ineligible for benefits. I think retirement is out of the question for a couple of years. I will check this out with Fr. Patrick Pollard of PRMAA. Fr. Paprocki will try to be in touch with Dilla within the next week or so.

Cardinal Bernardin, Fr. Paprocki, John Canary and I met to talk about several priests on July 12. The situation with Fr. Frank Dilla was discussed.

We all agreed that Dilla is a very emotional man at this time and that his actions of ignoring the Cardinal's prohibition against saying the Mass for his sister were not so much the actions of a rebellious man as they were of a frightened and fearful person. Paprocki has prepared a penal precept for him which will be delivered this week. He will be told to return to supervised residence and his salary will be similarly restricted. I should notify [REDACTED] of this decision once it has been made and promulgated to Dilla.

In our conversation the other day with Fr. Paprocki, you mentioned the possibility of retirement. At the time, I asked about your social security situation. You indicated that there might be a problem.

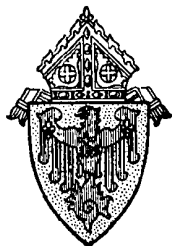

I spoke to Patrick Reardon, who is acting as a friend and lawyer for Fr. Frank Dilla. Peter Shannon referred Dilla to Reardon. Dilla was to go to the Retreat House on August 1. Fr. Paprocki and I extended that date to the 3rd. Now Dilla says that he is very serious about retiring. I spoke to Fr. Patrick Pollard at PRMAA about the Dilla situation recently. There is a possibility that Dilla could retire. Pollard pointed out that Dilla is due exactly \$869.00 monthly were he to retire at this time. This money would come from Aetna.

The remaining money could be paid from the FRA salary list until such time as he would get on Social Security. He would be officially retired with two sources of income. He would pay income tax on both the salary from us and the pension from Aetna. That way he could continue to get his quarters. At this time Dilla probably has no more than 19 quarters. He needs 38. I then called Pat Reardon, who is out of town this week, to inform him of this as a possibility. We would want Dilla to retire as soon as possible. I shall call Frank Dilla.

Fr. Dilla is a client of our office and of your office as well. On 10/12/93 I informed you that, through an error in my computation he has been receiving \$17.93 a month less than he is due. This amounts to \$53.79 since he did not receive this money during July, August or September. Re-payment should be made to that amount.

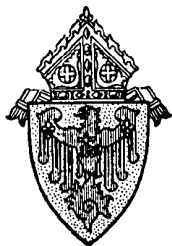
In addition, Fr. Dilla has not submitted his transportation costs for July, August and September. Because of his car payment of \$315 per month, plus additional mileage costs for [REDACTED] he should receive the full \$433 per month for July, August and September. This amounts to \$1,299.

For October, 1993, his check should be \$1,257 plus \$433 for transportation. That comes to \$1,690 for October.

After this month, I believe that Fr. Dilla will be retiring and thus be eligible for money from his pension. As soon as that amount is determined I will get back to your office to give you the new figures that you will be responsible for from November onwards.

Fr. Dilla came to see me on 10/12/93 accompanied by Rev. Daniel Sullivan ('53). We discussed options for retirement for Fr. Dilla.

I. AT PRESENT:

1. Through the Fitness Review Administrator (FRA) office, Fr. Dilla receives \$1257 per month, without transportation, without stipends for Masses.

Included in this amount is base salary - \$530.00
frozen increment for seniority - \$366.67
less 10% contribution - (\$ 89.67)
housing supplement - \$450.00

total - \$1257.00/month.

2. In addition, Dilla is eligible for transportation costs of up to \$433.00 per month. Fr. Dilla has a car payment of \$315.00 until May 31, 1994, [REDACTED]

new total - \$1690.00/month.

II. UPON RETIREMENT:

1. Upon retirement, Dilla would be eligible for an \$869 per month payment from the pension fund.

In addition until 5/31/94, Dilla will automatically receive the full transportation allowance of \$433.00 monthly. Thus each month until 5/31/94, the FRA will send Dilla a check for \$821.00. 3. After May 31, 1994, when his car payments are completed, Fr. Dilla will have to apply for this transportation supplement each month to the FRA. That means that, from June, 1994 on, Dilla will receive a monthly check from the FRA for \$388 [REDACTED]

4. Each year the FRA will pay one/half of Fr. Dilla's yearly social security payment. Frank will have to submit his tax form to the FRA office on his own.
5. The FRA will also provide the yearly \$650 for professional growth expenses when Fr. Dilla submits invoices.
6. After checking other sources, I found that regular stipends are available only from the Chancellor. Catholic Charities cannot provide stipends. Frank will have to apply directly to the Chancellor for stipends.

(Fr. Dilla did not apply for the \$433.00 transportation subsidy for July, Aug., Sept. of 1993. He is therefore owed a check for \$1299.00, plus a back check for an additional \$53.79 to represent the amount he was underpaid on his regular check for the months of July, Aug., and Sept. 1993.)

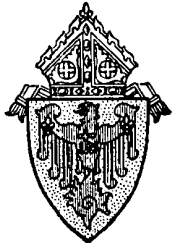

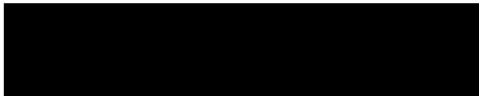

In our last phone conversation, you had asked that I inform you of the restrictions which Fr. Frank Dilla has been placed under as a result of his original misconduct and subsequent failure to observe the Cardinal's restrictions.

I have delayed responding so that I might work out with Fr. Dilla the details of his retirement. As of Nov. 1, 1993, Fr. Frank has submitted his request for retirement and the Cardinal has accepted it. Fr. Frank is no longer on the active role of priests for the archdiocese.

In addition, the Cardinal has determined that Father Frank's priestly faculties to exercise public ministry are permanently withdrawn. He is forbidden to exercise any public ministry liturgically or sacramentally. He is allowed to offer Mass, but only in a private setting.

In his retirement, he will continue to reside in his home at New Carlisle, Ind. The diocesan authorities in the area where Fr. Dilla lives have been notified of his presence and of the restrictions to which he is subject. He will be monitored regularly by his counselor and by our office. Other restrictions imposed are:

- He must not be in the presence of minors without another adult being present.
- He must abstain from alcoholic beverages.
- He must continue for the rest of his life in his recovery program as determined by competent authorities.

From a priest's point of view, the restrictions of his priestly faculties are quite drastic. For all intents and purposes, Fr. Dilla will not function as a priest publicly ever again.

It has come to my attention that Cardinal Bernardin has accepted your request to retire from active ministry. As a result, I am writing to clarify the canonical implications of your retirement.

First of all, please note that your retirement does not affect the Cardinal's precept imposing restrictions on you, dated July 12, 1993. This canonical precept remains fully in force even in retirement. Another copy of this precept is enclosed for your reference.

Secondly, I wish to explain some of these restrictions more specifically. The provision that you may continue to celebrate Mass privately means only in the privacy of your home in New Carlisle with one other person present to assist you. You may not anywhere or under any circumstances, celebrate Mass or any religious services for a group of people, no matter how small. This includes services such as baptisms, weddings and funerals for friends and relatives. Moreover, you are reminded that you are forbidden to be alone with minors and you are not permitted to drink alcoholic beverages. The penalty for violation is automatic suspension.

Frank, I regret that this letter must be so stern, but I hope you can appreciate the need to have absolute clarity about these restrictions.

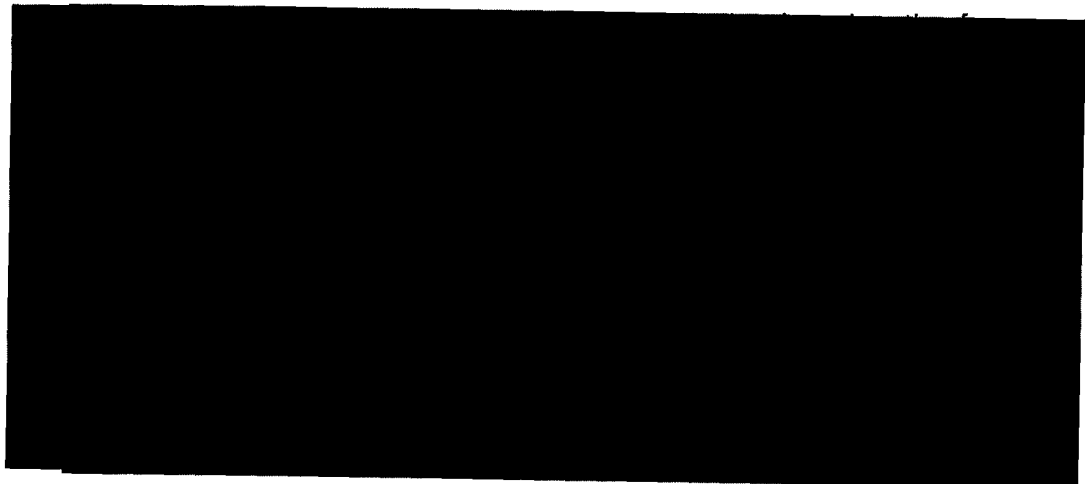

Recently I visited a client of our office, Fr. Francis Dilla, in retirement. At that time he told me of a problem that he is having. As you know, with the recent repairs that he had to have made on his car, he has fallen into some financial problems. In attempting to get him enough quarters for social security, we also find that his 1990 social security tax was not paid. That bill amounts to \$2,228 plus \$536.12 for accrued interest fines. It's obvious we need to help him with this debt.

May I suggest that we forward him a loan for \$2,764.12. Again, I will work out some sort of payment plan for him.

Enclosed you will find the original bills that you gave me on Monday, Dec. 27. By the way, I enjoyed the lunch with [REDACTED]. Their hospitality helped make the trip very pleasant.

I have sent John Curran, who is working with senior priests, copies of your two bills. I have given John your telephone number and he will be contacting you about the bill from the New Carlisle Eye Associates and the notice from Gallagher and Bassett.

I also contacted Pat Pollard of PRMAA about the dilemma with the Internal Revenue Service and your social security payment. He is sending me a check to cover that amount of \$2,700 +. I will send that on to you as soon as I get it. This makes a total of \$4,200 which PRMAA has loaned you in the very recent past. I think the best way to handle it would be to make some kind of a monthly payment to PRMAA. It might work best if you were to send a monthly check made out to PRMAA to our office. We'll send it on to PRMAA. I would suggest an amount anywhere between \$25 and \$50 per month based on what you can reasonably pay. There will probably be an additional penalty from the IRS for late payment of the social security amount, but it shouldn't be too much and you should be able to handle that on your own.

Fr. Dilla came to see me today as part of a regular check up.

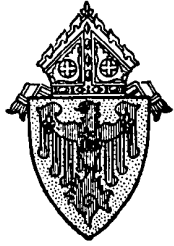

Fr. Dilla came to see me today. He talked about the bills that he has accumulated because of excessive medical expenses. His physical condition is not getting any better. He does have an arthritic spine as well as some eye problems at present to add to all his other difficulties.

Just recently there has been a cut in his pay after his payments for his car stopped. This was all part of a previous agreement.

He has been receiving for the past year a \$450 per month housing supplement. What with insurance, yearly taxes, utilities, food, and the monthly payment on the mortgage, which amounts to \$300, his expenses come to almost \$1,000 per month for the house. [REDACTED] is able to contribute something, but she only receives a check from Social Security of about \$600 per month. The question is whether it would be possible to raise his monthly housing allowance from \$450 to \$650. The men at the Retreat House will cost us about \$7-800 per month. We have to keep in mind that outside of [REDACTED] costs, we are not paying anything else for Dilla. I will make some inquiries as to whether this is possible.

I spoke to Fr. Dilla on 12/10/94 at [REDACTED] He wants me to know that he is continuing to have serious problems with his [REDACTED] The combination of the [REDACTED] along with the [REDACTED] really has laid him low. [REDACTED]

I encouraged him to stay in touch with the consultant from Catholic Charities and I told him that I would have the consultant get back in touch with him. My concern is that his inability to get around is going to escalate and his bills will also escalate. He was recently taken to the hospital in an ambulance. The Medicare refused to pay it saying that he could have gotten there in another fashion. This is one of the areas where the consultant could be helpful to him.

My own concern is that somewhere down the line, it may well be that Fr. Dilla will have to be hospitalized in a more permanent care situation. At present he is living with a care-taker and that is working out fine. We will need to keep a watch on his situation for his own good.

I spoke to Fr. Mark Holihan on 12/12 to refer this matter once again to the consultant. He will ask the consultant to be more aggressive in following up with Fr. Dilla.

Presenting problem: Allegation arose in Jan. 1992, going back 25 years to around 1967. [REDACTED] alleges Fr. A abused her when she was about 6. [REDACTED] alleges he did the same thing to her [REDACTED] about six years before when the older one was 6 or 7. The [REDACTED] has never come forward. Nor has a [REDACTED] who has no recollection of abuse.

[REDACTED] While acknowledging the abuse, Fr. A states that it happened approximately three or four times at the most. She alleges it happened about once a week for a year when he was visiting the family. No other allegations have arisen. [REDACTED]. She has been informed as to how Fr. A is being dealt with.

I would like to clarify the salary and transportation allowance that is sent to you through the Vicar for Priests Office. Our office is responsible for the following:

Annual Salary: \$7,745

26 pay periods: \$297.88 per pay period

Annual Transportation Allowance: \$5,846.04

Monthly payment: \$487.17

We made a change by separating the transportation from the salary, so for the new fiscal year you will receive a separate monthly transportation check for \$487.17. The check you will receive for salary will come from payroll in the amount of \$297.88. In reality, there is no change from last year in the amount of money you receive from this office other than the two items will be accounted for separately.

The last check you received in the amount of \$409.39 covered one week's salary and transportation from the last fiscal year and one week's salary for the new fiscal year. You will receive the transportation allowance for the month of July in the amount of \$487.17 when this is properly set up in the finance office.


Dear Frank,

We are in the process of reviewing salaries and benefits for the FY2004-2005. Your situation came up for discussion and, in light of the history related to monies you received from our Office and ultimately the Pastoral Center, we can no longer justify the monthly stipend and transportation benefit sent to you. Upon examining your file, I again became aware that you retired in 1997. As a result of retirement, you receive a monthly pension of \$1,032.75 in addition to social security benefits. None of the priests who are on retirement benefits receive additional funding from the Archdiocese. Dr. Carol Fowler, Director of Personnel Services, reviews personnel salaries which includes those priests who are or have been supported by the Archdiocese. In consultation with our office, we agreed that the annual stipend of \$7,745 for room and board will be discontinued effective July 1, 2005. Further, the monthly stipend for transportation, \$483.17 will no longer be sent to you. When I examined the reason for this stipend, I learned that it was authorized through the Professional Responsibility Office for the purpose of transportation [REDACTED]

I realize that the above amounts of monies became sources of income upon which you depended and that it may be difficult to relinquish this dependence. However, I trust that you can also see the predicament of the archdiocese given its grave financial situation.


Following is a timeline regarding payments for room and board (sometimes considered salary from this office) and transportation to Frank Dilla.

11/1/93: Frank Dilla took early retirement. (Actual year for retirement was 1997.) Salary received from two sources: Aetna pension and PFRA. (Monthly \$388 salary, \$433 transportation)

1994: Received a loan of \$4200 from PRMAA to assist with car repairs. Made return payments monthly @ \$100.

6/17/94: Vicar requested of the Cardinal an increase in housing allowance from \$450 to \$650. Mileage payment was calculated on mileage submitted and amount given per mile (\$.28) at the time.

12/97: 

1996-97: Agreement made with PFRA that F. Dilla would receive the following reimbursement for room/board and transportation: \$645.38 – room/board; \$483.17 – transportation. In 1999 these payments were transferred to Vicar for Priests Office and last year to Interim Salaries. These amounts have not changed since 1996.

3/26/02: Conversation regarding present payments was reopened. F. Dilla rejected the idea of not receiving allowance for transportation and

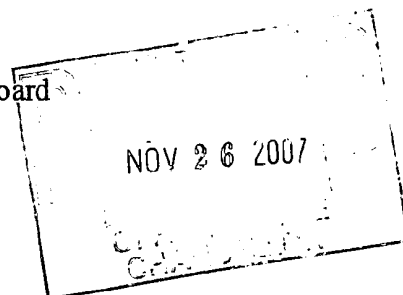

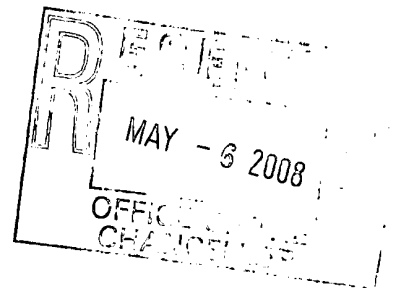
