**Matter of PFR-31 (J.O.):**

1. The Administrator reported to the Board, pursuant to Article 4.7(c), that on 3-16-94 a [REDACTED] had called the Office 800# and briefly described that a Rev. Joseph Owens at St. Philomena's Parish had sexually abused her as a minor and set-up for a further phone conversation to discuss the matter in detail with the Administrator the following day. The Administrator informed the Board that in the interim before his call to [REDACTED] on 3-17-94 the Chancellor Rev. Tom Paprocki informed the Administrator that J.O. was "away without leave" as a priest and had been gone from the priesthood since leaving St. Philomena Parish in 1970. The Administrator informed [REDACTED] of that fact on 3-17-94, assured [REDACTED] he would send her policies, and explained how an in-person meeting might still be a possibility to gather further information about her allegation, although the Board would not be able to proceed through its process due to no priest to request a response from nor enough information to permit reasonable inquiry as a result.

2. The Administrator also informed the Board that [REDACTED] was informed about the presence of our Victim Assistance Ministry and that on 3-22-94 [REDACTED] called back to cancel her proposed lengthy phone conversation with the Administrator on that date to further detail the allegation and that she felt she needed more time.

3. The Board confirmed the appropriateness of the Administrator's responses and directed the Administrator to again clarify to [REDACTED] in their next phone conversation that the Board will not be able to proceed formally in the matter but that she should feel free to contact our Victim Assistance Ministry should she so desire.



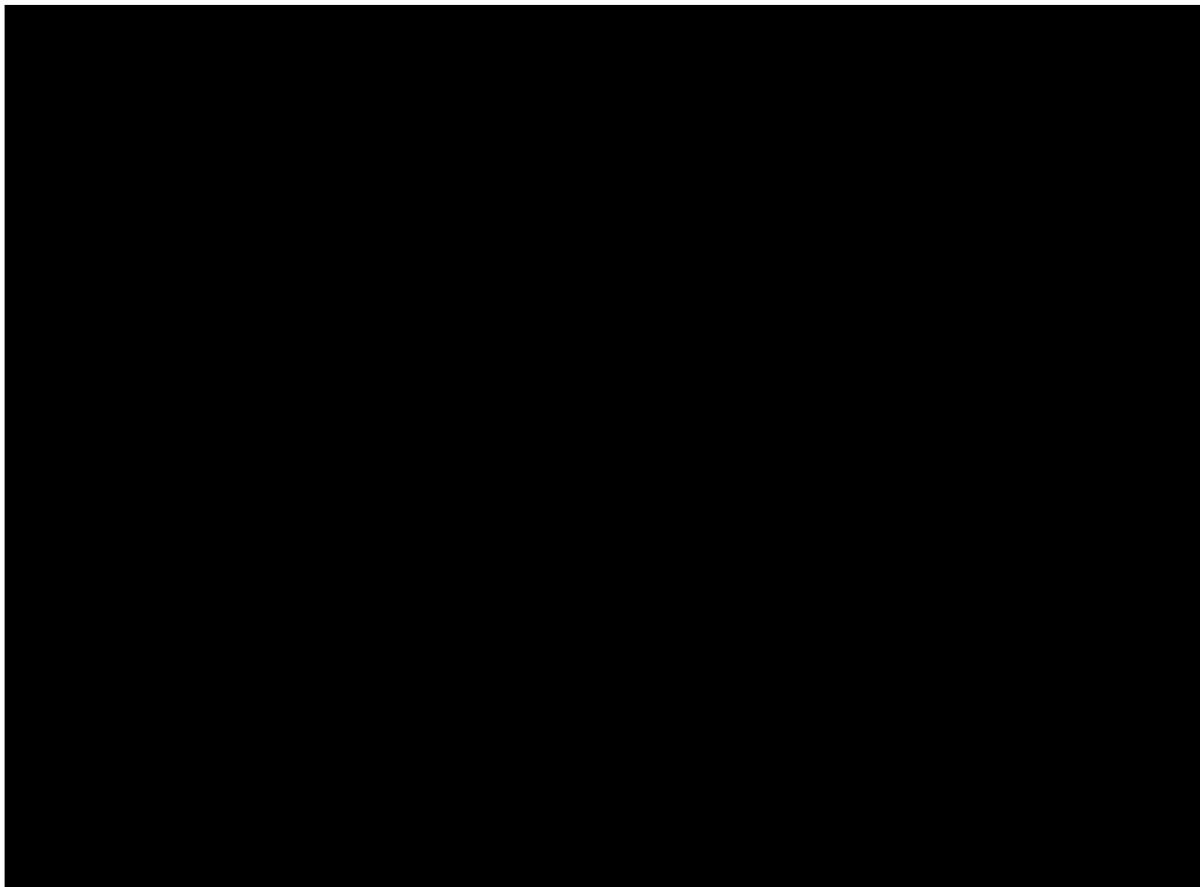

**Matter of PFR-31 (J.O.):**

1. The Administrator informed the Board that he had received information pertaining to a new allegation of sexual misconduct as a minor from a [REDACTED] involving a Rev. J.O. The Board was informed that J.O. left his ministry as a priest in 1970 although he was never formally laicized. The Board was informed that [REDACTED] was informed of that information and invited to contact Assistance Ministry. The Administrator informed the Board that he had arranged for a phone conversation with [REDACTED] this coming week to discuss the situation further.

2. The Board directed the Administrator to re-iterate (the Administrator had already so communicated) to [REDACTED] that the Board would not be able to proceed formally through its review procedures in that there is no priest to request an explanation to the allegation from. However, the Board suggested that the Administrator explain to the alleged victim that her allegation has been documented in a formal file, also for the purpose of in case any other persons would come forward an allegation against J.O. in the future.

### Jimmy Lago, Chancellor

- Mr. Lago was invited to the Review Board meeting by [REDACTED], Chair to discuss recent events in the Archdiocese of Chicago
- [REDACTED] asked Mr. Lago to discuss his new position [in regards to matters of cleric sexual misconduct with minors], the Archdiocese's new agreement with DCFS, [REDACTED]

[REDACTED]

- Mr. Lago began by explaining that his new position he has been appointed to by Cardinal George has to do with his responsibility to now coordinate the responses of all offices regarding the sexual abuse allegations; he also spoke of the [positive] unintended effects of strengthening the Archdiocese's internal policies/practices regarding reporting abuse cases to DCFS; he also referenced the training of Archdiocesan employees and volunteers
- Mr. Lago spoke about the agreement with DCFS and that DCFS asked the Archdiocese to "step aside" until their [DCFS] investigation is completed in such cases
- Mr. Lago talked about the need of the Archdiocese to clarify with DCFS that the diocese does not want to wait "forever" prior to following through with our own investigation/follow up of a report of the alleged abuse of a minor by a cleric
- Mr. Lago stated that he does not feel that this agreement with DCFS will affect the Board and its work
- Mr. Lago spoke of issues and need for clarification with DCFS on the reporting of old cases that have been substantiated by an archdiocesan process; Mr. Lago stated that he would discuss this matter with DCFS for clarification
- Mr. Lago talked about the need to sharpen reporting and training of archdiocesan employees and the possibility of involving the Child Advocacy Center [CAC], as the CAC has offered its assistance with training
- Mr. Lago stated that the reporting of all [old] substantiated cases to DCFS may assist the Archdiocese with accused clerics who have left the priesthood [locating clerics if their whereabouts are not known; determine if children are at risk]
- Mr. Lago feels that the Archdiocese will share more information with DCFS on old cases; this raised the concern that if DCFS "finds" an old case that the Archdiocese has found to be unsubstantiated
- [REDACTED] raised the question of a time line with DCFS when they are investigating a case and the delay that this may cause with the Archdiocese and related process
- [REDACTED] suggested the need for clarification from DCFS as to when the 14 days of their initial investigation begins to determine if DCFS will formally open a case for investigation

- As for the monitoring report, Mr. Lago spoke of the fact that the Archdiocese does not have the power of the courts, but that we don't really have a monitoring program; as per the report, Mr. Lago spoke of the need for evaluation and therapeutic intervention for those priests who have substantiated allegations of sexual misconduct with minors against them; Mr. Lago spoke of the need for conversation to ask if the Archdiocese can put elements into place for an effective monitoring program
- Mr. Lago stated that the Archdiocese has pulled together a group of eight that will be given the consultants' reports [as the Review Board will be given copies of the reports as well] and ask, "What kind of things do you think we [the Archdiocese] should start with?"



- [REDACTED] spoke of [REDACTED]'s past recommendation of having a treatment facility for men with substantiated allegations against them; a treatment facility that would offer specific sexual offender treatment
- [REDACTED] referred back to Mr. Lago's comments regarding DCFS; [REDACTED] expressed his concerns with the information [as a result of their investigations into a matter] that DCFS would or would not give the Archdiocese and then the concern with the time lost by the Archdiocese while DCFS investigates a case
- [REDACTED] suggested that it would be helpful if the resigned/laicized priests with substantiated allegations could be placed on the DCFS Registry
- The group engaged in a discussion of forced laicization of men with substantiated allegations against them, both the positives and negatives of such, and the need to protect children
- Mr. Lago offered to return to meet with the Board members if/when appropriate to share information as we go forward; all present agreed with the preference that Mr. Lago come back to report to the Board as the Archdiocese continues forward in addressing all discussed matters
- [REDACTED] expressed his concern to Mr. Lago of the release of Review Board members' names

On August 11, 2006, PRAA spoke with [REDACTED] who is the principal of the North Side Catholic Academy. PRAA asked if she had any record there of a teacher by the name of [REDACTED] who would have taught at St. Gertrude's Grammar School – now the North Side Catholic Academy. [REDACTED] checked her records and said she did not have any record of [REDACTED]. She said she believed that the majority of records from the time period described might be housed within the Archdiocesan Archives.

PRAA emailed [REDACTED] of the Archdiocesan Archives office and asked him to forward to her attention any contact information he may have on [REDACTED] from the files archived from St Gertrude's Grammar School. [REDACTED] responded and suggested PRAA contact [REDACTED] of the schools office.

PRAA contacted [REDACTED] who forwarded a Teacher Termination Maintenance Form for [REDACTED]. [REDACTED] said that all paper files prior to 1980 have been destroyed. She also said that [REDACTED] did not teach long enough to qualify for a pension, so she cannot be tracked through that system.

The Teacher Termination Maintenance Form lists [REDACTED]'s last employment site for AOC as Gordon Tech from 9/84 until 6/87. There is no contact information listed for her. It confirms her as working at St. Gertrude's from 9/64 until 6/67.

On August 16, 2006, PRAA spoke with Fr. Kenelley, the former pastor of St. Gertrude's Parish. Fr. Kenelley said he did not know Fr. Owens and that Fr. Owens had been

there before he (Fr. Kenelley) had arrived there. He suggested PRAA contact Fr. Flavin (██████████) who currently is the Pastor at Our Lady of Perpetual Help in Glenview, IL. He said he believes that Fr. Flavin may have known Fr. Owens during the time he taught at Quigley. PRAA left a voicemail message for Fr. Flavin and requested he return her call.

On August 18, 2006, PRAA spoke with Fr. Flavin. He said he did not remember much about Fr. Owens. He does not know if Fr. Owens was in charge of the altar boys while he was at St. Gertrude's. He recalls observing children (probably boys) being allowed to go into his bedroom. He recalls observing this a few times. He does not remember anything else. He said most of the priests who had also been at St. Gertrude's when Fr. Owens was there are now deceased. Fr. Flavin also recalled that Fr. Owens seemed to be a private person who kept to himself in his bedroom frequently. When asked if he could think of anyone else PRAA could contact regarding Fr. Owens, He suggested PRAA speak with Fr. Tom Healy who had also been at St. Gertrude's around the mid 1960's.

PRAA contacted Fr. Healy (██████████). He said that he left St. Gertrude's in 1964. He recalls the pastor who he still talked to after he left being very upset with Fr. Owens. He recalls Fr. Owens being described as being very difficult to work with and trying to organize parishioners against the pastor. He does not remember hearing any concerns or observing anything unusual with Fr. Owens in regards to children.

He said he might know of someone who may remember if Fr. Owens was in charge of the altar boys. He asked for PRAA's contact information and said he would call her if he were able to gather any more information. PRAA thanked him for his help and said she would also be happy to contact anyone he thought could be helpful if that would be easier for him. He said he would keep that in mind.

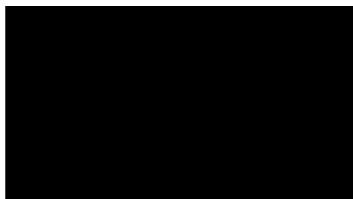



PRA received a phone call today from [REDACTED] at attorney [REDACTED] office regarding a new client, Mr. [REDACTED]. As per [REDACTED], Mr. [REDACTED] has an allegation of sexual abuse against the former Rev. Joseph Owens. When asked by PRA, [REDACTED] read from [REDACTED] notes that Mr. [REDACTED] alleges that Fr. Owens abused him sometime in the late 1960s while a student at St. Gertrude. [REDACTED] also stated that Mr. [REDACTED] alleges that Fr. Owens abused him between sixth and eighth grades and that he graduated from the grammar school in June 1967. PRA informed [REDACTED] of the preference to meet with [REDACTED] face to face, if that was a meeting that he would be interested in scheduling. [REDACTED] informed PRA that Mr. [REDACTED] does not have the financial means to travel to Chicago. PRA then asked that [REDACTED] determine if Mr. [REDACTED] would be interested in meeting. If so, the financial cost could be discussed to be covered by the Archdiocese of Chicago.

[REDACTED] appreciated the information from PRA and stated that she would discuss the matter with [REDACTED]. It was agreed that PRA would wait to hear from [REDACTED] on how to move forward with Mr. [REDACTED] allegation against Fr. Owens.






PRA spoke with Rev. John E. Flavin via phone today regarding the confidential investigation of Mr.  allegation of sexual misconduct against the former Rev. Joseph Owens. Mr.  allegation against Fr. Owens is one of two current allegations against him. Fr. Flavin's assignment to St. Gertrude's included 1967 when Fr. Owens was assigned there as well. He is currently assigned to Our Lady of Perpetual Help and may be reached at .

PRA began by informing Fr. Flavin that he was contacted in connection with a confidential investigation of an allegation of sexual misconduct against Fr. Owens. Fr. Flavin did not immediately respond to PRA, but did finally agree that he had some time to speak on the phone regarding this matter.

PRA was able to confirm with Fr. Flavin that he was assigned to St. Gertrude's in the late 1960s, which is where Fr. Owens was assigned for a short period of time as well. When asked by Fr. Flavin, PRA was able to confirm for him that Fr. Owens was assigned to St. Gertrude's from May 1966 through May 1967. PRA was also able to confirm Fr. Flavin's memory that Fr. Owens resigned from the priesthood shortly after leaving St. Gertrude's [1970].

Fr. Flavin stated that he did not know Fr. Owens very well nor did he spend much time with him. During the aforementioned time period, Fr. Flavin was living at St. Gertrude's, but was also teaching at Quigley. Therefore, Fr. Flavin spent most of his time during the weekdays at Quigley and was not around St. Gertrude's. When asked by PRA, Fr. Flavin did confirm that he was around St. Gertrude's on the weekends.

During the phone call with PRA, the only information that Fr. Flavin volunteered [without being asked by PRA first] was that he does not believe that Fr. Owens was happy at St. Gertrude's. When asked later in the phone conversation by PRA, Fr. Flavin

agreed with PRA's suggestion that Fr. Owens was not happy with his assignment at St. Gertrude's.

PRA asked Fr. Flavin if he recalls any inappropriate behavior on the part of Fr. Owens and/or if he recalls the cleric spending any inappropriate amounts of time with minors. As per Fr. Flavin, considering the combination of the amount of time that has passed since being assigned to St. Gertrude's, not knowing Fr. Owens well, and not being able to recall, he would not be able to say for certain one way or another if Fr. Owens had children in his room or not.

PRA then asked specifically if Fr. Flavin recalled/observed any inappropriate behavior on the part of Fr. Owens. Fr. Flavin seemed irritated with the question and again sighted the amount of time that has passed and his unfamiliarity with Fr. Owens, but stated that he does not recall seeing any inappropriate behavior on the part of the accused.

PRA did not reveal the name of Mr. [REDACTED] or the other alleged victim of Fr. Owens to Fr. Flavin.

Almost immediately after PRA thanked Fr. Flavin for his time, the cleric seemingly abruptly ended the phone call.

### **Conference Call**

This meeting took place entirely via conference call. PRA arrived at the Vicar for Priests' Office for the 11:00am scheduled meeting. PRA and Rev. Edward Grace then contacted Mr. Joseph Owens via phone.

When asked by PRA, Mr. Owens stated that he did not have any initial questions or concerns prior to hearing the allegation. PRA provided Mr. Owens with basic information regarding the Office of Professional Responsibility and its role in receiving allegations of sexual misconduct of minors by clerics of the Archdiocese of Chicago.

Both PRA and Fr. Grace noted [upon ending the phone call] that Mr. Owens was extremely well spoken. He also appropriately participated in all conversations that took place during the September 29, 2004 phone call.

Mr. [REDACTED] allegation of sexual misconduct against Mr. Owens was the second of two allegations to be read to him during the scheduled meeting [refer to Mr. Owens' response to Mr. [REDACTED] allegation]. When asked by PRA, Mr. Owens stated that it was not necessary to send him a copy of Mr. [REDACTED] allegation against him.

PRA then read Mr. [REDACTED] allegation of sexual misconduct against the former Rev. Joseph Owens without interruption.

Upon the conclusion of PRA reading the allegation, Mr. Owens stated, "I must say, I am astonished... [I was] not a perfect priest, but I didn't [abuse any minors]." In reference to Mr. [REDACTED] allegation, Mr. Owens stated that the first floor of St. Gertrude's rectory consisted of a sitting room and two offices, none of which had any books in them. Mr. Owens also stated that the "...the timing is wrong..." in regards to Mr. [REDACTED] statement of when confession took place at St. Gertrude's. He referred to the other priests who were assigned to St. Gertrude's at the time and stated that he is "...shocked at the length of time of the incidents [as alleged by Mr. [REDACTED] and Mr. [REDACTED]]."

Mr. Owens stated, "I had nothing to do with either incident [of alleged abuse by Mr. [REDACTED] and Mr. [REDACTED] respectively]." He continued by stating, "I won't call them [Mr. [REDACTED] and Mr. [REDACTED] liars, but [he would call the alleged victims] confused... I suspect that the two [Mr. [REDACTED] and Mr. [REDACTED] came forward together."


Mr. Owens stated that he would pray for both Mr. [REDACTED] and Mr. [REDACTED]. He then stated that there is no veracity to either allegation presented to him on September 29, 2004. Referring to a past statement of his own, Mr. Owens again stated that he "...particularly doesn't like the allegation of lifting the curtain [in the confessional]..." as alleged by Mr. [REDACTED].

When PRA indicated his right to have copies of both allegations forwarded to him, Mr. Owens stated that he intended to change his phone number after the September 29, 2004 meeting. He continued by stating that he "...does not want any part of this process past this point [and that he] wants nothing [allegations or a copy of §1100 Sexual Abuse of Minors: Policies for Education, Prevention, Assistance to Victims and Procedures for Determination of Fitness for Ministry] forwarded to me."


PRA thanked Mr. Owens for his response to Mr. [REDACTED] allegation. Both Fr. Grace and PRA thanked Mr. Owens for his time.
